The Laurel Alice Williams Foundation was founded in 2008 by Kathy Pace Williams and Ken Williams, parents of Laurel Alice Williams who was killed in a drunk-driving accident in October 20, 2007 at the age of 19 in Pleasanton, California.

Our mission is two-fold:

- To provide an annual endowment in the form of a scholarship to an individual transferring from Las Positas College to a four-year university as Laurel was planning to do, and a second endowment to a Foothill High Senior, where Laurel graduated in June 2006.
- To promote the expansion of Safe Rides, a life-saving service for teens by teens, to provide free and confidential rides on weekend evenings as a safe alternative to driving or riding with someone under the influence. The program will be expanding into the San Ramon/ Danville area. Safe Rides currently operates in Pleasanton through the help of Boy Scouts of America.
